



YMCA Wellness Partner Membership Agreement

Overview of our Partnership

We are excited to begin a new partnership with the (companyname). It is our goal to help your employees become healthier in spirit, mind and body.

Wellness Partner Membership Details

The (companyname) has a wellness program in place that provides employee incentives for participating in wellness programs. Effective (starting date), the DuBois Area YMCA will launch a corporate membership for your company. This will include:

- Waiving the joining fee for any membership for all of your employees. (Joining Fee rates vary between locations).
- Providing an ongoing 20% reduction in the standard monthly membership fee for any Adult membership (excludes Senior and Senior Family). The 20% reduction is for new and existing bank draft YMCA members at any of the branches included in our Wellness Partner Membership agreement. Existing annual payment members are eligible for the discounted rate upon renewal.
- The (companyname) employees who wish to become new YMCA members will receive the Wellness Partner Membership rate when they sign up for a membership at the DuBois Area YMCA or at their Regional YMCA Alliances location.
- When signing up, the employee will simply provide a proof of employment or a pay stub from your company.
- The (companyname) employee with an existing membership at the DuBois Area YMCA, and their Regional YMCA Alliances, will need to go to their home branch and provide the same identification or pay stub to begin receiving the Wellness Member Benefit.

The Wellness Partner Membership will continue unless terminated by either the (companyname) or the DuBois Area YMCA by providing 30 days written notice of termination.

Under this Wellness Partner Membership Agreement, a minimum of 10 employees are required to participate within 90 days of this signed agreement. This will be reviewed annually to review participation. Should the average number of employees participating in this program fall below the required minimum for any year, the YMCA may discontinue this Agreement.

Benefits to Wellness Partners and their Employees

- Access to 2 DuBois Area YMCA locations and their Regional YMCA Alliances members
- Variety of free wellness-related classes
- Free Child Watch (babysitting services) when scheduled
- Free personal wellness consultations – 3 per member
- Priority program registration with reduced member rates for programs
- Reciprocity within the state of PA which allows use of any YMCA in the state as long as you use your home YMCA 51% of the time.

Commitment from Wellness Partners to insure a successful program

- YMCA will provide space once a year for partner group gathering/event (Team Building, Family Night, Corporate Challenge, Health Fair, etc.)
- Maintain a minimum of 10 employees participating at the YMCA
- Provide the YMCA access to your employees through on-going YMCA developed e-mail, newsletters and other communication. These will be emailed to the main contact person and, when approved by the (company name) forwarded on to your employees or made available via the intranet site.
- Communication may include opportunities for your employees to volunteer, attend special events or fundraising activities.
- Allow the YMCA to place mutually-agreed-upon information about your benefits in your new employees orientation packets.
- Provide information about the YMCA to be posted on your employees intranet site if available/permissible.
